**NOTIFICATION**

No.SO(DC)814/2003 (A-97) (P). The following draft of the proposed amendment in the Punjab Drugs Rules 2007, which the Government of the Punjab proposes to make in pursuance of section 44 (1) of the Drugs Act, 1976 (XXXI of 1976), is hereby published as required under section 44 (2) of the said Act for information of the persons likely to be affected. Notice is being given that the said amendments, together with any objection or suggestion with respect the draft rules (amendments), which may be received by the Secretary to the Government of the Punjab, Primary and Secondary Healthcare Department within fifteen days i.e. upto **23.02.2016** of the publication of this notification in the official Gazette, shall be taken into consideration. It is further clarified that any objection or suggestion received after the stipulated period shall not be considered.

**DRAFT AMENDMENTS IN PUNJAB DRUGS RULES, 2007**

In the said Rules:

- 1) in rule 2, in clause (g), for the word "Health", the words "Primary and Secondary Healthcare" shall be substituted;
- 2) in rule 3:
  - a) in clause (a), for the word "Health", the words "Primary and Secondary Healthcare" shall be substituted;
  - b) in clause (b), for the expression "Additional Secretary (Technical) to the Government, Health Department", the expression "Additional Secretary (Drugs Control) to the Government, Primary and Secondary Healthcare Department" shall be substituted; and
  - c) in clause (c), for the word "Health", the words "Primary and Secondary Healthcare" shall be substituted; and
  - d) in clause (i) for the word "Health", the words "Primary and Secondary Health" shall be substituted; and
- 3) in Form No.07, in Serial No.2, for the world "Health" the words "Primary and Secondary Health" shall be substituted.
