NO.SO(ND)2-26/2012. Governor of the Punjab is pleased to accord sanction to the admissibility of Non Practicing Allowance (NPA) to the Dental Surgeons who do not opt for private practice as per rates given below with immediate effect:-

Sr. #	BPS	Rate per month
11	17 & 18	Rs.4000/-
2	19 & 20	Rs.6000/-

- Governor of the Punjab is further pleased to accord sanction for Qualification Allowance amounting to Rs.5000/- with immediate effect for FCPS, MD and MS, equivalent to M.Phil, will be given as per criteria laid down by the Government of the Punjab. Additionally, general cadre medical officers/woman medical officers having qualification of FCPS or equivalent, serving in THQ Hospitals will also be eligible for Punjab Health Sector Reforms Programme Allowance (PHSRP) with immediate effect as per Government Policy issued vide No.PO(P&E-I)19-113/2004(v) dated 13.04.2007 and subsequent amendments from time to time in this regard.
- 3. Governor of the Punjab is further pleased to accord sanction that take home stipend of PGs for 1st year PG Trainees shall be equivalent to 90 percent of take home salary of newly inducted regular Medical Officer, posted in Lahore with immediate effect. Simultaneously, second year PG Trainee shall get stipend equal to 90% of the take home salary of Medical Officers in 2nd year of service and such formula shall apply till 5th year PG Trainee. The 5th year will be allowed as per CPSP criteria.
- Governor of the Punjab is further pleased to accord sanction that the stipend of House Officers shall be indexed by linking it to the periodic revision of basis pay scales. This will be on the same formula as at present i.e Rs.24,000/- as a multiple of the initial basic pay of BS-17 with immediate effect.
- Governor of the Punjab is further pleased to accord sanction that an increase of Rs.1200/- will be added in the Health Professional Allowance (HPA) across the board with immediate effect. Indexation of HPA will also be made in accordance with the revision of basic pay scale. This will be on the same formula as at present i.e. Rs.15,000/- as a fraction of initial basic pay of BS-17 and Rs.10,000/- as a fraction of the initial basic pay of BS-18 and above.
