NOTIFICATION (PART-A):

NO. SO (Stand) 423/2016: Departmental Standardization Committee of (SHC&ME) Department in its meeting held on 20.09.2016 approved the Product Vocabulary Medical Stores (PVMS) of following nine (09) clinical specialties along with the instructions to make use of PVMS.

i. Cardiology, ii. Ophthalmology, iii. OT & General Surgery, iv. Gynecology, v. ENT, vi. Orthopedics, vii. Pediatrics, viii. Anesthesia & Ventilations, ix. Dental

The same is hereby notified for use with immediate effect and strict compliance.

INSTRUCTIONS:

- I. The procuring agency shall define the quantities of accessories according to the requirement with the machine.
- II. The procuring agency may delete any of the accessories which are mentioned in the PVMS for not being the requirement of that particular procuring agency.
- III. The procuring agency shall define the quantities of items required for purchase mentioned as optional in the PVMS.
- IV. The end-user shall provide clinical and technical details/ justification for the purchase of optional items to the Head of Institution / Hospital before proceeding for the purchase. The same will be recorded and retained by the hospital administration for future reference.
- V. The procuring agency may conduct Pre-bid meeting which will only be permissible for the purpose of clarification to vendors regarding equipment standard features, accessories and optional requirement. However in order to ensure the generalization and quality of specifications, changes in the specifications will not be permitted.
- VI. Minor deviations in sizes and ranges of different features of medical equipment will not be considered as reason of rejection, which will be determined by the Technical Evaluation Committee of the procuring agency.
- VII. Procuring agency may initiate process for the purchase of any specialized equipment, not available in the approved PVMS list, with valid justification(s). The procuring agency will certify about the generalization of specifications. The specifications of that specialized equipment shall only be advertised after the approval of the SHC&ME Department.
- VIII. All procuring agencies under the administrative control of SHC&ME Department will be bound to use the notified PVMS. The amendments and additions according to the latest technological advancements, clinical and technical requirements will be issued by the SH&ME Department, as and when required.
