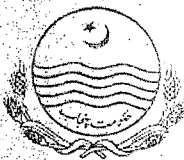

SUBJECT: CRITERIA FOR EXTENSION IN DEPUTATION CASES.

I am directed to refer to the subject cited above and to state that it has been observed in the Finance Department that the requests for extension in deputation are invariably processed by the Administrative Departments as a routine. Sometimes extension in deputation is repeatedly sought for years without providing cogent justification. Need has thus been felt to revisit our process and purpose of allowing extension in deputation.

I am further directed to request that henceforth the cases for extension in deputation may only be forwarded to Finance Department, if the following parameters are adhered to:

- i) The Administrative Department concerned should furnish following details to the Finance Department:-
 - a) Individual's contribution and performance,
 - b) Organizational need and
 - c) Peculiarity of skill otherwise not available.
