The meeting started with the name of Allah. The members of the committee scrutinized the grievances of the firms participating in the tender of Medicine in Bulk for the year 2017-18 and the following decision^s were made:-

1. Grievance filed by M/s Haji Medicine regarding the rejection of tender item No.29 Inj. Heparin 5000 i.u. (Rotex Medica). Representative of the firm was heard in detail and the comments of enduser was brought into their notice as these drugs are life saving and the end user has strict reservation about its usage due to high risk associated with it.

Decision

Since there is no facility available in Pakistan for testing of Inj. Heparin, the committee asked the company for provision of international certification for quality of Inj. Heparin and to provide further samples to the concerned department for detailed clinical trial as early as possible to consider in future if results upto the standard.


Hence grievance of M/s Haji Medicine is rejected.

2. Grievances filed by M/s Bosch Pharmaceuticals regarding the rejection of items No.38 and 57 (Inj. Meronem 500mg and Inj. Vancomycin 500mg on sample evaluation basis. The representative of the firm was heard and comments of end user was conveyed to him.

Decision

Grievances of Bosch Pharmaceuticals are accepted on following conditions;

- Provision of supporting documents by company, regarding quality of mentioned drugs: DTL Reports and other certificates.)
- Rectification of any query when required.



3. Grievances filed by M/s Nova Med regarding the rejection of items No.72, 73 and 78 (Tab Atenolol 100mg, Tab Atorvastatin 20mg and Tab. Clopidogril 75mg) on sample evaluation basis. The representative of the firm was heard and comments of end user was conveyed to him.

Decision

Hence the grievances of M/s Nova Med are Rejected


