The members of the committee carefully scrutinized the grievances of the firms M/S Umair Enterprises and M/S Hope pharma participating in the tender of Surgical & Disposable Items for the financial year 2017-18 and the following decisions were made:


1. **M/S Hope Pharma** vide this Hospital diary No. 833, dated 21.02.2018 has filed grievance of tender item No. 04 (Polypropylene Mesh) regarding the rejection of products on samples evaluation. The end user was not satisfied with the results of product. Thus, grievance committee decided that the decision of end user stands so.
2. **M/S Umair Enterprises** vide this Hospital diary No. 911, dated 26.02.2018 has filed grievance in the tender items No. 03, 04 & 05 (Specimen Bag, Polypropylene Mesh all size & Disposable Orthopedic Drape). Item No 04 (sample rejected) and Item No 03 & 05 (sample not provide).


In case of item No. 04 (Polypropylene Mesh) sample was rejected by end user. The end user was not satisfied with the results of product. Thus, grievance committee decided that the decision of end user stands so.

In case of items No. 03 & 05 (Specimen Bag & Disposable Orthopedic Drape) (sample not provided), the firm had failed to provide samples in front of sample inspection & grievance committee inspite of numerous reminders. Thus, the grievance committee rejected the grievance of these items and decided that the decision stands so.
