The terms & conditions of placement shall be as follows:-

1. Duration of the Course will be Two year Duration of the Course will be two years out of which one year placement is allowed extendable for second year subject to satisfactory performance.
2. They will draw their salary and other allowances from their parent institution.
3. They shall have to bear the expenditure of tuition fee, pre-enrollment fee, all diploma fee. Transport charges and mess charge etc. at their own.
4. They shall be required to maintain proper discipline and satisfactory progress of work (including minimum of attendance 85% or as fixed by the Institution.
5. They will be repatriated to her institution at any stage during the course, in case her progress and conduct is found un-satisfactory.
6. The shall not leave the Course incomplete, failing which they shall be liable to refund the entire amount spend on her training along with any penalty as determined by the Head of the Institution or which may be imposed by the Government.
7. They will be liable to be debarred for the period of three years applying admission in any course and the refundable security will also not be re-funded, in case they leave course incomplete.
8. They shall be required to serve the Government for a period of three years on completion of her course during which she will not be allowed to apply for any second PG training course or others.
9. The academic credentials including experience certificate will be verified within 30 days. In case any document is found **BOGUS**, Not only her admission will be cancelled but FIR against her on the charges of forgery will also be registered in the concerned Police Station and she will never be considered for any admission in future. Disciplinary proceedings against her under Punjab government Servants PEEDA-Act-2006 will also be initiated.
10. All students shall not be allowed to indulge in any study program in any other College/University. If any student is found indulge in any other Program their admission will be cancelled and disciplinary proceedings under PEEDA-ACT-2006 will be initiated.
11. Their placement shall be further subject to terms and conditions given in the prospectus of Postgraduate College of Nursing Punjab Lahore-2015-16 and placement policy formulated by the Health Department, Government of the Punjab from time to time..
12. Their placement will be cancelled in case she is not proved to be the regular employee of the Health Department or if any enquiry is found pending/
13. During training their conduct will be governed all other Rules & Regulations (teaching/ training) of the Postgraduate College of Nursing Punjab.
14. They shall report to the Principal, Postgraduate College of Nursing (PGCN) Punjab, Lahore within one week (07 days) of the issuance of this letter, failing which:
 - a) Their service will be placed at the disposal of Director General Nursing Punjab, Lahore/Health Department for further posting in some rural area.
 - b) They will also stand debarred for any PG training course both inside and out side the country for a period of three years.


