The Regularization of the service of the officers shall be subject to the following terms & conditions:-



- vii. This appointment / regularization shall be governed under PCS (A&C) service rules, 1974 and policies / rules issued by the Punjab Government from time to time.
 - viii. This appointment is subject to verification of documents by the Department Authorities and of antecedents by the Police. If any false information is found to have been furnished by the officer in the process of verification, her service shall be liable to be terminated forthwith.
 - ix. The appointment on regular basis shall be prospective in nature and the officer shall have no right of entitlement to any back benefits
 - x. The inter-se-Seniority of the officers with the regular cadre shall be fixed on the basis of the date of their initial contract. In case, the candidates having the same date of appointment, their seniority shall be determined according to their age/date of birth.
 - xi. The officer will not be entitled to any TA/DA for presenting herself before a Medical Board for examination or for joining on her appointment.
 - xii. In case, the officer accepts this offer of appointment on the Terms & Conditions mentioned above, she is required to communicate her acceptance in writing to the concerned authority within fifteen days from the date of notification.
