### **TERMS & CONDITIONS:**

- i. That your appointment is subject to your being physically fit, you will require appearing before Standing Medical Board and getting yourself declared medically fit before joining. The date of your medical examination will be communicated to you by the authority concerned.
- ii. That you will not be entitled to any TA/DA to present yourself before the Standing Medical Board.
- iii. That you are not married to a foreign national and you have to submit a declaration to that effect.
- iv. That you will be required to join the place of your posting at your own expense and no TA/DA will be paid.
- v. That you will be governed by such Service Rules as may be issued by the Government from time to time.
- vi. That you will be liable to serve anywhere in the Punjab.
- vii. That your seniority will be in accordance with the order of merit assigned by the PPSC, irrespective of actual date of joining.
- viii. That your appointment will be subject to fulfillment of the condition (if any) imposed by the PPSC.
- ix. That if, at any stage, it is discovered that you obtained appointment on the basis of forged/bogus documents, the appointment shall be considered to be void ab-initio and you shall be liable to refund all amounts received from the Government, in addition to such other action as may be taken against you under the rules.
- x. That you will remain on probation for a period of two years which is extendable to another two years. If during the period of probation, your work & conduct is

found un-satisfactory, your services will be liable to be terminated at one month's notice without any reason being assigned or on the payment of one month's salary in lieu of the notice. In case, you wish to resign at any time, one month's notice will be necessary or in lieu therefore, a month's pay will forfeited.

- xi. In case, you accept the said post on the aforementioned conditions, you should report yourself for duty to the concerned Principal / Medical Superintendent, DHQ/Teaching, THQ Hospitals etc. within fifteen days from the date of its receipt.
