District Health Departments (whose District Governments authorized the Health Department) and Directorate General Health Services, Punjab i.e., Procuring Agencies (DHQ, THQ Hospitals, RHCs, BHUs in Punjab & Additional Director Health Services (MS&DC) O/o DGHS Punjab), during the financial year 2015-16, shall issue notifications of award/advance acceptance of tender (AATs) and subsequently contract and purchase orders against the rate finalized by the Health Department after receipt of Performance Security in the form of an Irrevocable Bank Guarantee equivalent to 5% of the total contract amount & stamp duty @ 25 paise per every 100 Rupees of the total value of the contract (0.25% of the total value of the contract). The contracts shall be awarded strictly in accordance with approved specifications and rates mentioned above against each item. *Further, the ordered quantity of each item shall not go beyond the demand of the item submitted by Directorate General Health Services, Punjab, in the Health Department and subsequently advertised in the bidding document.* Directorate General Health Services, Punjab, shall notify the quantity of above mentioned items district wise.

3. The receiving of stocks shall be as per approved specifications and testing & inspection shall be done by the District Health Departments strictly in accordance with the terms & conditions of the advertised bidding document. Payments shall be made after verification of quantity, quality and after fulfillment of all prescribed legal & codal formalities prescribed in the bidding document. Bidding document is available on the official website of the Health Department i.e., (www.health.punjab.gov.pk/tenders).

4. All lowest evaluated bidders are bound to abide by all terms and conditions of bidding document. In case of failure to comply with any terms & conditions of bidding document and this notification, District Health Departments can initiate legal action against the firms or they may refer the case to Health Department for lawful action.
