NOTIFICATION

NO(Nursing & AHSE)-6-14/2016. In continuation of earlier Notifications/Circulars Nos. SO(TRG) 6-40/2012 dated 09.09.2014, SO(TRG) 6-87/2009 dated 26.06.2013, SO (TRG)6-35/2011 (P), 13.05.2015 and SO(TRG) 6-40/2012 dated 23.12.2014, the Competent Authority has been pleased to make following further amendments in Admission Policy for various Nursing Specialization Disciplines/Courses and Post RN B.Sc. Nursing (two years) Degree Programmes from Academic Session 2015-16 as under:-

A. **Revised Break-up of total 50 sanctioned seats for Post R.N. B.Sc (Nursing)**

Regular Seats :	40
Private Seats :	10
Total Seats	50

B. **Revised Selection/Merit Criteria for admission into Post R.N. B.Sc (Nursing)**

Maximum 05 marks for Extra Professional qualification (02 marks for one year specialization diploma and 03 marks for Post graduation/Nursing Management & Nursing Education.

C. **Revised Admission Policy for in-service candidates for various Nursing Disciplines against the Private Seats**

The Nursing Officer having minimum of one year regular service at her credit shall also be eligible for admission **against private seats.**

D. **Revised Selection Criteria for one year specialization nursing disciplines.**

- i. Aggregate marks percentage in General Nursing + Midwifery

- ii. 85 % marks weightage will be included in merit while determining merit.

- iv. Maximum 05 marks for extra professional qualification on the following break up:-

Note:

As Nursing Examination Board never grant Gold Medal or Silver Medal, therefore, no extra marks to the candidates having Honour, gold medal or silver medal shall be awarded while determining merit.

E. Absence during course

Those students who will avail more than 30 days leave/absence during the training will not be allowed to appear in the final examination. However, after completion of short lectures/period and 85 % attendance, the candidate will be allowed to appear in the supplementary examination (only one chance) conducted by the University of Health Sciences, Lahore or Nursing Examination Board, Punjab, Lahore, as the case may be.


2. The above amendments will take effect from Academic Session 2015-16.
