The Punjab Day Care Fund (PDCF) Society, under the administrative control of the Women Development Department, Punjab, was established in 2012 to support working women by setting up Day Care Centers (DCCs) in public sector organizations across the province. As per PDCF guidelines, interested institutions must provide space for the DCCs as co-financing, while the Society funds equipment and staff salaries for one year.
