CORRECTION IN NOMENCLATURE OF THE POST AS PER SERVICE RULES

I am directed to refer to the subject noted above and to state that it has been observed that Punjab Health Department Allied Health Professionals (Service) Rules, 2012 (amended 2015) were enforced in 2012 (**copy enclosed**), wherein the post of Technologist (Pathology) (BS-17) is available. The posts of Microbiologist (BS-17), Medical Technologist (BS-17) and Biochemist (BS-17) were included in 4-tier service structure Notification/Up-gradation as missing categories w.e.f. **24-11-2011** vide Splashing of posts Notification dated **22-06-2021**. As such, these posts have not been made part of Punjab Health Department Allied Health Professionals (Service) Rules, 2012, their nomenclatures have become redundant and need to be corrected in line with the nomenclature of such posts existed in Punjab Health Department Allied Health Professionals (Service) Rules, 2012 i.e. Technologist (Pathology) (BS-17).

2. It is observed that following nomenclature of the posts existed in your respective University / Medical College / Institution / teaching hospital may be got corrected as per Punjab Health Department Allied Health Professionals (Service) Rules, 2012 to make the posts useful and liable to be filled:

- i) Medical Technologist (BS-17)
- ii) Microbiologist (BS-17)
- iii) Biochemist (BS-17)
- iv) Medical Laboratory Technologist (BS-17)
