I am, therefore, directed to request that the issuance of computerized/typed medico-legal reports to the Investigating Officers (IOs) be ensured to facilitate seamless investigations in cases registered under the Anti-Rape Act, strictly in accordance with the directions of the Hon'ble Chief Minister, Punjab.
