I am directed to refer to the subject cited above and to enclose herewith a complaint No. **MSM25LH40007386**, dated 24.12.2025 received from Advisor RO Lahore (LH-4) office of Ombudsman Punjab, Lahore, alleging therein that PGRs and House Officers are deprived of accommodation, while hostel rooms have been illegally occupied by unauthorized persons and doctors, who are not performing duties there. Further, Senior Faculty Members are also forced to hire expensive accommodations on rent due to this irregularity.

2. I am, therefore, directed to request to look into this matter and take necessary action for vacation of hostel rooms from un-authorized persons and same rooms may be allotted as per merit / policy to the entitled person only.

3. It is also requested to inquire into the matter and submit a report within 07 days to **Section Officer (Liaison)**, SHC & ME Department for onward submission to the office of Ombudsman Punjab, Lahore.
