## **TERMS & CONDITIONS:**

- They will be governed by Punjab Civil Servants Act 1974 and Punjab Civil Servants (Appointment & Conditions) of Service Rules 1974 and the service Rules as may be issued by the Government from time to time.
- They are not married to a foreign national. They should submit declaration to this effect to government.
- iii. They will remain on probation for a period of two years which is extendable upto four years. During the period of probation, their services will be liable to be terminated on one month's notice without assigning any reason or on the payment of one month's salary in lieu of the notice if they were previously not in government service or revert them to their former post (if they were in service previously) but after confirmation they will be governed by the provisions of the relevant service rules.
- iv. They will be bound to attend emergency duty assigned by the authority at any time. For private practice, they will not be allowed to open any clinic, dispensary nursing home, private hospital, clinical diagnostic laboratory or a pharmacy / drug shop.
- v. Their appointment is subject to physical fitness. In case they have not been declared fit by the Standing Medical Board on their first entry into Government service as gazetted Government servant, they should report to the Director Health Services Punjab, Lahore alongwith X-Ray and Skia-gram of their chest and number of glasses if used and re-vaccination certificate for producing before Standing Medical Board on a date which will be communicated to them by the Director Health Services, Punjab. They require to produce Medical Fitness Certificate before joining.
- vi. If they fail to appear before the Medical Board on the prescribed date without good and sufficient reasons reported in writing in advance, their offer will be deemed to have been withdrawn automatically and no further correspondence shall be entertained on the subject.
- vii. They will not be entitled for any TA/DA to present themselves before the Medical Board for examination on joining their first appointment.
- viii. Their credentials / degrees / Certificates shall be got verified from the concerned Board / University / Institution / PNC. In case, degrees / certificates of academic qualification / any other particular documents or information submitted by them are subsequently found to be bogus / forged / incorrect



etc., the offer of appointment shall be withdrawn (apart from any other action on ground of criminal offense) in terms of regulation No. 32, 71 of the PPSC Regulation 2000.

- ix. They will be liable to serve anywhere in the Punjab.
- x. That if, at any stage, it comes into notice that they have obtained appointment on the basis of forged / bogus documents, the appointment shall be considered to be void ab-initio and they shall be liable to refund all amounts received from the Government exchequer, in addition to such other action as may be taken against them under the law.
- xi. The appointment is subject to condition that the selectees / appointees shall not avail any opportunity of transfer / posting within two years after their appointment except in cases of wedlock, widow and divorce.
- xii. The disabled / special person will be required to appear before the Special Medical Board for re-verification of disability and suitability to discharge their functions / duties at place of posting.
- xiii. Their seniority will be maintained in accordance with order of merit assigned by the PPSC irrespective of actual date of joining.
- xiv. They are directed to report for duty to the Medical Superintendent / Department concerned within fifteen (15) days from the date of issuance of this order.
