 - All cardiac institute(s) / tertiary care hospitals in Punjab (hereinafter called Procuring Agency), mentioned in this notification, will be responsible for issuance of Advance Acceptance of Tender / Notification of Award / Purchase Orders and immediate completion of further procurement process as per rate finalized for framework contract for current financial year 2024-25.
 - 6. Each procuring agency will sign contract with the supplying firm, after receipt of Performance Guarantee (1% of the total contract value) in the form of instrument defined in the bidding documents and 0.25% stamp duty of total value of the contract. The contract shall be awarded strictly in accordance with approved specifications, notified quantities and rates mentioned above against each item.
 - All records will be maintained by both, institutes / hospitals and successful bidders and these records will be shared with Specialized Healthcare & Medical Education Department by the successful bidders, on monthly basis.
 - 8. The delivery period is 45 days for all items from the date of issuance of contract / purchase order.
 - Payments shall be made by the concerned procuring agency, after due verification of quantity, quality and fulfillment of all prescribed legal and codal formalities.
 - 10. Being signatory of the contract, each procuring agency will be entitled to initiate legal action against the delinquent supplier firm.
