No. SO(TAX)1-10/2025-26. In exercise of the powers conferred under section 5 of the Punjab Sales Tax on Services Act 2012 (XLII of 2012), Governor of the Punjab is pleased to make the following amendments in Second Schedule of the Act *ibid.*, with immediate effect:

AMENDMENTS

In the Punjab Sales Tax on Services Act 2012, in Second Schedule:

- (1) in Part I, at Sr. No. 1:
 - (a) in column No. (2), for the existing entry, the following shall be substituted:

PROPOSED AMENDMENTS IN THE SECOND SCHEDULE OF THE PUNJAB SALES TAX ON SERVICES ACT, 2012

Finance Act, 2025, has amended the Punjab Sales Tax on Services Act, 2012 (Act XLII of 2012) and substituted its former positive-list framework with a Negative List (i.e. tax-exempt services) by replacing its two Schedules: the First Schedule now lists tax-exempt (Negative List) services, while the Second Schedule—organized into three Parts—deals with varying rates of taxable services. Hence, the Punjab Finance Act, 2025 has recast the Act, which is a major transition.

57.2 After the said amendments, serial number 1 of the Part-I of the Second Schedule has become a general entry of taxation, which deals with the standard rate of tax (i.e. 16%) for all services, except those specified in the serial numbers 2 and 3 of the same part (Part-I), and the services specified in Part-II and Part-III. Part-II relates to the fixed taxed services and Part-III relates to the reduced rate services. Serial number 1 of the Part-I of the Second Schedule is reproduced below for ready reference:

The tax statute always follows the rule of strict interpretation. Thus, the language of tax statute must be clear and unambiguous to clearly reflect the spirit of law. Plain reading of the column number 2 of the serial number 1 suggests creation of exception for serial numbers 2 and 3 of all parts (Part-I, Part-II and Part-III) of the Second Schedule, instead of restricting it to serial numbers 2 and 3 of the Part-I only. The Act categorically stipulates different rates of tax for the services specified in the Part-II and Part-III of the Second Schedule. The spirit of the Act and ambiguity in the existing entry number 1 is further described as under:
